Subject: Resolution No. 28-2022 - A Resolution Adopting the 2022-2024 Strategic Plan

BACKGROUND / DISCUSSION

Strategic planning is the process by which a town determines what it intends to achieve in the future and how it will get there. This process involves the elected Board of Trustees developing a vision for the Town's future and determining the necessary goals and priorities to achieve that vision. A strategic plan serves as the community's roadmap, and it is used by staff to prioritize initiatives, goals, projects, resources, and department operations. The strategic plan is a big-picture document directing efforts and resources toward a clearly defined vision. Town staff will be responsible for prioritizing and planning specific projects and operations based on the overall goals and themes outlined by the Board of Trustees in the Strategic Plan. To see strategic planning in action, please look at the table below that outlines a few of the 2021 Town of Wellington Strategic Plan goals and projects that were prioritized and accomplished as a result of the guidance from the previous Town Board:

Growth and Development Goal 3: Comprehensive Plan – alignment and execution	The final Comprehensive Plan was adopted in August 2021

Infrastructure Goal 3: Create opportunities for transportation and storm water management improvements	The Town started the Stormwater Master Plan in the fall of 2021 and has received \$1.8 million in funding through grants to complete transportation and drainage improvements along Cleveland Avenue.
Community Engagement Goal 1: Build awareness about the Town of Wellington services and programs	The Town created a monthly newsletter and created additional social media platforms with increased engagement rates.

A compensation study was also completed in 2020 and additional studies will be completed every 2 years to ensure competitive employee attraction and retention.



The 2022 strategic planning process began in April 2022 following the election of the new Board of Trustees. The Town hosted a Strategic Planning Community Town Hall at the Leeper Center in April. It was well attended by at least 50 residents of the Town. During this Town Hall, the community was invited to provide their thoughts and answers regarding their vision and goals for the Town as individuals as well as in small groups. This allowed the residents to prioritize the numerous goals they hoped the Town would accomplish. Please see Attachment A to reflect the sticky note responses from individuals at the Town Hall as well as Attachment B which reflects the small group priority themes presented that night by the community.

The second form of engagement was a virtual feedback survey for residents that were unable to attend the inperson Town Hall meeting. We received 123 responses to the survey. Please see Attachment C for the survey responses.

The Board of Trustees were provided insight from the community engagement during their Board Workshop in April 2022 and this guided their discussion of creating Board Priorities. Please see Attachment D for Board Priorities from the Workshop. Several themes remained consistent between the feedback received at the Town Hall, through the virtual survey, and at the Board Workshop. These themes were incorporated into the first draft of the 2022-2024 Strategic Plan document which was discussed at the Board of Trustees Work Session on July 12, 2022 and July 26, 2022.

Please see the Attachment E for the redlined document which outlines comments and changes requested at the July 12, 2022 Board of Trustees Work Session and Attachment F for the redline document which outlines comments and changes requested at the July 26, 2022 Board of Trustees Work Session.

Tonight, staff is continuing to look for direction from the Board of Trustees regarding the mission and vision statements, the 4 pillars, the goals that fall under each pillar, the language used to describe the goals, and any items they feel are missing or not necessary to include. This is the guiding document that staff will utilize when prioritizing projects, operations, and budget requests for the next 2 years and it is important that it reflects the intentional direction of the Board of Trustees.

BACKGROUND / DISCUSSION

On July 12, 2022, the Board of Trustees was presented with an ordinance concerning utility billing changes. The direction of the board was to have staff research potential issues concerning tenants having utility accounts in their names. After further discussions, staff is proposing that this item be brought back after the first of the year. The purpose of delaying this item is for the following reasons:

- 1) The Town is currently undergoing a utility rate study. Based on the outcome of what is decided about the rates and how the billing will change, it is unclear how the code will be affected, and more changes may need to be addressed in the future.
- 2) Staff has been collecting data from both tenants and landlords, trying to gain a full understanding from both sides of the current state of how these accounts are being handled and what can be done internally for process improvement. Once a standardized utility billing process is set, staff can properly analyze what communications are needed moving forward.
- 3) Further training needs to be done with staff on the software system and on how to best utilize the tools and resources that the Town currently has in place regarding the landlord/tenant accounts.

ORDINANCE NO. 14-2022

AN ORDINANCE AMENDING CHAPTER 13 OF THE WELLINGTON MUNICIPAL CODE CONCERNING UTILITY BILLING PROCEDURES

WHEREAS, the Town of Wellington, pursuant to Chapter 13 of the Wellington Municipal Code, provides utility services to residents and customers; and

WHEREAS, portions of Chapter 13 have not been followed as unnecessary for the operations of the municipal utility;

WHEREAS, the Town of Wellington Board of Trustees desires that the rules and procedures of the Town billing department be clear to residents and customers; and

WHEREAS, the Town of Wellington Board of Trustees desires that the fees charged by the Town for late fees, serving notice, and service termination reflect the actual costs of the Town.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF WELLINGTON, COLORADO, AS FOLLOWS:

1. Section 13-1-80 of the Wellington Municipal Code is amended as follows, with underlined potions indicating additions and strikethroughs indicating deletions:

Sec. 13-1-80. - Water service initiation.

- (a) Application for initiation of service or transfer of billing. Application to have water turned on or transferred from one (1) party to another shall be made in writing to the Town Administrator. The Town may require written agreement by the applicant to abide by and accept all of the provisions of this Code pertaining to water or sewer service or other health, engineering or service limitations relative to service as conditions governing the use of the Town's Utility facilities by the applicant.
- (b) <u>Repealed</u>. <u>Utility service deposit required</u>, refund allowed. A refundable deposit of an amount established by resolution by the Board of Trustees to offset the Town's costs shall be required as a condition of providing any utility service to a customer under the following circumstances:
 - (1) Any new customer;
 - (2) Any customer who changes address to which utility service is furnished, except when such customer has been a nondelinquent customer during the most recent twelve-month period;
 - (3) Any customer who receives one (1) shut-off notice or two (2) delinquency notices within the previous year; or
 - (4) Any customer whose water service has been terminated because of delinquency.

Any deposit held by the Town, less any amount still due the Town for utility service, shall be refunded to the customer who paid the deposit after eighteen (18) months of continuous service wherein no delinquency or shut-off notice has been issued or when service to the customer is discontinued on a permanent basis, whichever occurs first. No interest will be paid by the Town upon refund of the deposit.

2. Section 13-1-90 of the Wellington Municipal Code is amended as follows, with underlined potions indicating additions and strikethroughs indicating deletions:

Sec. 13-1-90. - Payment of user charges.

- (a) Owner responsible for payment. The owner or owners of any building or premises connected with the Town water or sewer facilities shall be held and deemed liable for the payment of all Utility user charges levied against such building or premises. A tenant in possession of the premises may apply for service and agree to pay the User charges; however, this will not relieve the owner of his or her liability for water, sewer and storm drainage Utility charges levied against the property.
- (b) *Utility bills due and payable*. The Town shall issue Utility bills for Utility user charges in the Town's normal course of billing. All Utility user charges shall be due when service is provided. The User's failure to receive a billing shall not relieve the User of the obligation to timely Utility user charges before delinquency. Any Utility user charge becomes a Delinquent account if not paid in full on or before the twentieth day of the month after the User receives a billing for such Utility user charges. Water service to a delinquent water account may be discontinued until any Delinquent account is paid in full.

Upon becoming delinquent a late fee (penalty) of <u>five dollars (\$5)</u> one (1) percent of the deficiency shall be assessed against account balances each month if not paid after the 20th day of the month. Any Delinquent account may be charged reasonable attorney's fees and other costs of collection incurred by the Town.

3. Section 13-1-130 of the Wellington Municipal Code is amended as follows, with underlined potions indicating additions and strikethroughs indicating deletions:

Sec. 13-1-130. - Discontinuance of utility services by Town.

Water Utility service to a User may be terminated upon the failure of the User to pay the amount due on the utility bill on or before the twentieth day of the month, for the payment of a utility bill with an insufficient fund or no account instrument, for failure to comply with the conditions of an installment payment plan, for unsafe or hazardous service lines, for tampering in any manner with the Town's utility facilities, for failing to abide by water use imposed by the Board of Trustees or for violation of any of the provisions of this Article. Advance notice of the pending termination shall be given only

for the failure of a User to pay the amount due on the utility bill, or for the payment of a utility bill with an insufficient fund or no-account check.

- (1) Notice of pending termination of utility service. Any required notice of the termination of water service shall be served upon the User or owner of the property owing a delinquent utility account at least twenty four (24) hours ten (10) business days before the date the service is to be terminated. Such notice shall be taped to or hung on the door (door tag) to the address listed in the utility billing records which shall be sufficient to satisfy this requirement.
- (2) The notice shall contain the following information:
 - a. The account number;
 - b. The amount of the unpaid bill and the amount that must be collected in order to avoid shut off;
 - c. The date on which the utility service will be terminated if the unpaid bill is not paid in sufficient amount;
 - d. The employee(s) of the Town to be contacted to ask about the notice, and the telephone number and normal office hours during which staff can be reached;
 - e. That an additional <u>fifty dollar (\$50)</u> twenty-five dollars (\$25.00) service charge will be added to the bill if a service is turned off.
- (3) If a second or subsequent turn-off notice is delivered in a twelve-month period resulting in a service turn-off, a notice fee of twenty dollars (\$20) will be added to the bill.
- (4) Termination of service. Water utility service to a User may be terminated by turning off the water at the curb stop or at the meter, or by removal of the meter or in such other manner as determined by the town.
- (5) Restoration of service. Service to a property that has been terminated for service shall not be restored until:
 - a. The delinquent utility user charges have been paid in full, including penalties and the service fee(s) for service restoration; or
 - b. A service fee is paid for restoring services and the owner of the property served enters an installment payment plan with the Town. The Owner's agreement to an installment payment plan shall not satisfy the lien held by the Town against the property served.
 - c. The cause for termination has been corrected.
- 4. Section 13-1-150 of the Wellington Municipal Code is amended as follows, with underlined potions indicating additions and strikethroughs indicating deletions:
 - Sec. 13-1-150. Corrections in accounts.

The <u>Finance Director</u>, Utility Billing Clerk or Town Administrator is authorized to correct billing errors or make other adjustments to a User's account as may be appropriate to comply with this Chapter.

Subject: Board of Trustees Rules of Procedures

EXECUTIVE SUMMARY

BACKGROUND / DISCUSSION

Through conversations with members of the Board of Trustees, it has been considered that the Board adopt a new set of rules and procedures. These would be more detailed than what is currently in policies and resolutions adopted by the board, but less expansive than the Robert's Rules currently codified in the Wellington Municipal Code. The intent would be to have one manual for the board, covering general procedures, expectations, and rules of order that are approachable and useable in the context of a small town board of trustees.

Procedurally, the idea would be to pass two items: an ordinance and a board policy. The ordinance would repeal the resolution that adopted Bob's Rules and would also modify the Town Code where it dictates use of Robert's Rules. The ordinance would say that the rules of procedure of the board would be those adopted by the board. This gives the board the flexibility to decide its own rules.

Second, the board would adopt the manual as a board policy. The goal would be for this to be revisited by each "new" board and then readopted, giving each new board ownership of the rules for itself.

As to the rules of order, a large benefit would be codify those motions and actions that are used most of the time. The vast majority of board action is through a small handful of motions and the board can decide how to handle those. As a fallback, the rules could say that anything not covered will be decided according to Robert's Rules, allowing for something to be in place for those very rare occasions when an unusual motion is appropriate.

During the Attorney Update, this concept will be discussed with the board, a possible framework for discussion will be introduced, and then a suggestion for next steps to ensure board involvement in creating something that will work for the board.

The Law Enforcement Services Agreement for the Town of Wellington obligates the Larimer County Sheriff's Office to provide monthly reporting.

In meeting the contract, for the month of **June 2022**, the Larimer County Sheriff's Office maintained six deputies, one corporal, and one sergeant providing full-time law enforcement for the Town. In addition, one half-time investigator, one full-time desk deputy, and one full-time School Resource Officer assisted the town with law enforcement activities.

During the month of June 2022, non-assigned deputies spent a total of 80.78 hours in Wellington responding to calls, patrolling, and making contacts in the town.

During the month of **June 2022** there were **7.0** hours worked by Northern Colorado Drug Task Force.

Investigations – ongoing and active cases include:

Sex Crime - 2

Robbery - 1

Vehicle Theft – 1

Fraud/Forgery - 1

Death - 2

Of Note:

A male suspect was contacted and arrested during a traffic stop for driving as a habitual traffic offender. A Sheriff K9 responded to the scene and recovered 114 grams of methamphetamine and other drug paraphernalia from the suspect's vehicle.

Multiple on and off duty deputies responded to a structure fire of a residence on Whitetail Circle. Deputies assisted fire personnel in the evacuation of the only occupant of the residence, pets, as well as adjacent residences. Investigations and Victims Response Team responded to assist.

Deputies participated in additional DUI, Leadership, Extradition, Emergency Vehicle Operations, and Precision Immobilization Technique (PIT) training throughout the month.

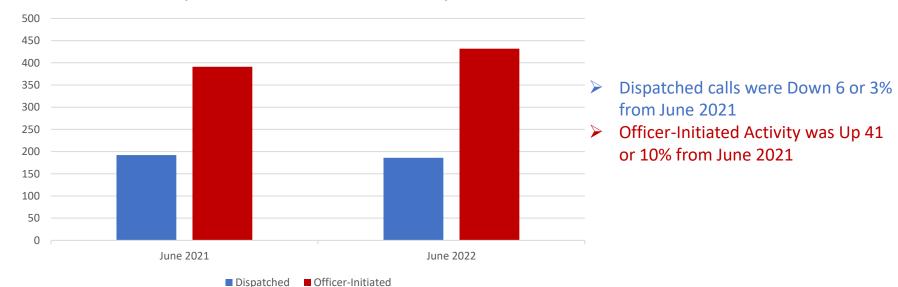

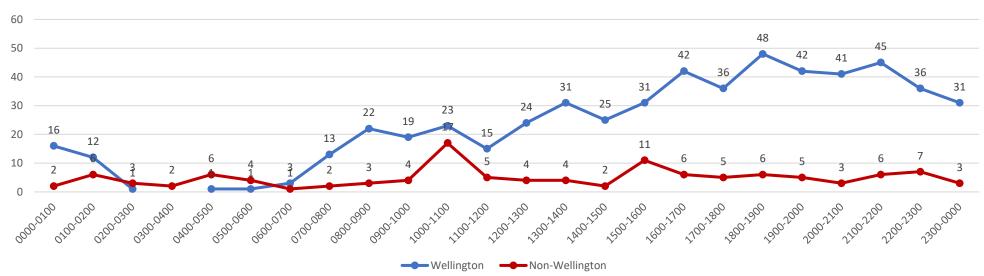

Contingency Update

 - This was required to replace the existing drying pad which was removed to start construction on the Step Feed Process Building and Aeration Basin. A smaller pad was constructed to replace the pad that was removed.
 - O Design changes from 90% Design Documents to 100% IFC Design Plans
 - The GMP was based on the 90% plans issued by Jacobs. The 100% "Issued for Construction" (IFC) plans include design revisions and additional detail. It is standard procedure to accommodate scope and cost changes at this stage of a project, and to draw from contingency if needed.
 - These design plan revisions resulted in both deducts and additions to the project. Town staff, Engineer (Jacobs), and Contractor (Moltz) met multiple times over several weeks to review the changes and the cost implications. Items added to the Contractor Contingency list were design changes (mostly structural or electrical in nature).
- Town Contingency
 - o Jacobs' Resident Project Representative (RPR) Contract Amendment Approved by the Board of Trustees on 5/24/22.
 - o Design changes from 90% Design Documents to 100% IFC Design Plans
 - As discussed above, IFC plans and specifications resulted in cost changes. Items added to the Owner Contingency list were largely based on revisions requested by the owner to benefit of the project.
