#### **BACKGROUND / DISCUSSION**

It was discussed at the March 14, 2023 Board of Trustee meeting that the Trustees would like to host an Advisory Board Appreciation Dinner in April, 2023. Trustee Tietz has offered to coordinate this event with the support of staff. Trustee Tietz will be presenting a proposed budget not to exceed \$5,000 for the event which would be paid out of the Board Discretionary Fund. This fund has a budget of \$20,000 for 2023 and nothing has been spent out of that fund to date. Trustee Tietz is working with Avuncular Bob's T-Bar Inn to host the event on April 26, 2023 and is soliciting pricing for appreciation gifts from local businesses.
